**Free Wills Legal Clinic-Eisai Inc. Pro Bono Clinic**—Wednesday, November 8, 2017 from 11:00 am to 2:45 pm in Woodcliff Lake, NJ. Sponsored by Eisai, a company that supports many of CancerCare's programs, including the Magnolia Meals at Home and their Healing Hearts Bereavement Camp. The free legal clinic is open to any NJ cancer patient in need for assistance in drafting a will, durable powers of attorney, and advance directives.

**To Apply:** Call Volunteer Lawyers for Justice, at (973) 645-1951 ext. 104, by **October 13, 2017** to start an application and to be screened for financial eligibility. To complete the application process, participants will be required to fill out a written questionnaire. Applications will be accepted on a first come, first served basis. Individuals will be notified of their application status by late October.

Free parking is available at the clinic and if transportation to and from the clinic is an issue, it can be provided.
