Summer Recreation – currently scheduling trips. Distributed copies of the year end reports that were submitted to Christ Eilert. The report includes the year end balances that need to be deposited into escrow in addition to the amounts that need to be reimbursed for the coach's certification and Instant Verification. Jazzercise is conducting classes. The class for seniors was too tough for them. I will see if she can either slow it down or give the free class to regular adults. All bills and referee fees for 2010 have been processed. Bills and referee fees for 2011 will not be processed until the books are turned over to 2011.
