Hearing of Citizens:

Ed Rendzio was in attendance on behalf of Recreation and Recreation Travel Basketball. Some positive and negative feedback was received for this past program. Gym time continues to be a problem. Senior WNBA was the most competitive division. Would like to possibly separate the in town recreation and the travel recreation and not make it mandatory to do both. Basketball would also like to have a tryout for the travel recreation teams. Doyle will be the place for all in town recreation. WRHS will be the place for all travel recreation. Basketball would like travel to participate in both North and South Bergen Leagues.

Leo Jones was in attendance on behalf of 24 Hour Fitness. They are forming a 1st and 2nd grade tiny tots program. Six weeks long, \$45. Children receive a shirt and trophy. First hour is 1st graders, Second hour is 2nd graders. Fundamentals include right hand vs. left hand ball handling and dribbling. Program is held on Saturdays in the spring. They will provide flyers for us to post and distribute. Mr. Jones also offered use of his facility for practice time. (\$10 per child) Ezio will speak to Paul Sarlo about this.

Unfinished Business/Committee Reports:

- a. **Dennis Brubaker:** Jr. Wrestling will host their end of year on March 26th.
- b. **Jerry Lanzerotti:** Attended youth night in place of Dennis Brubaker. His counterpart was Robert Morrone, Senior at Bergen Tech. The night went very well. Track and Field currently has 48 registered.
- c. **John Gingerelli:** Girls Softball and Little League Parade to be held on April 9th. Registration went well. Numbers are high. Babe Ruth is also running well.
- d. **Emil Bevacqua:** Indoor Soccer went very well this year. Complemented Nick Cipriano on once again running a great program. Fall soccer will hold their meeting next week. Soccer did not approve the use of the soccer goals at the WRHS Field and has since locked up the goals. Spring camp offered by US Sports will be held mid-April. Mike Carcich Baseball Camp is all set for Spring Break week. Went to see the Golf Program in action. Very well run. Would like to fit it into our current sport offerings.

- e. **Toni Ann Azzolini:** Nothing to report.
- f. **Bryon Parisi:** - Basketball still needs to set up monthly meetings so that parents can attend and stay informed. Competitive Cheering went to Nationals in Virginia.
- g. **Ezio Altamura:** Gave a brief update on the drainage project and retaining wall project at the Wood Ridge Sports Complex.
- h. **Recreation Report (Jacki Goldklang):** Joe D'Angelo would like to hold a New Jersey Ask Prep Course. Recreation Commission does not want to offer at this time but suggested he approach the library. See New Business (Summer Recreation). Haley Muoio would like to coach and is questioning whether or not she needs certification and fingerprinting. She is not the head coach and can help out without requiring certification. Email was sent to all of the groups in conjunction with the Memorial Day Parade. May 1st is the deadline to respond.

New Business:

Summer Recreation salary set for Directors at \$379 includes the 2012 borough increase and the movement of staff to the next level. *Motion was made by Emil Bevacqua to set the Directors salary at \$379 and to move the returning counselors to the next salary level. In the event that one of the Directors does not return this year we will not rehire the position but will rework the existing set up. Motion was seconded by ToniAnn Azzolini. Vote taken; all ayes. Motion passed.*

Motion was made by Emil Bevacqua to set the registration fee for Summer Recreation to \$110 for one child, \$70 for each additional sibling (\$110 for one, \$180 for two, and \$250 for three, \$320 for four or more siblings). Motion was seconded by ToniAnn Azzolini. Vote taken; all ayes. Motion passed.

Joe Zielinski will be honored at the May meeting if he is available. We will give him a clock for his 12 years of service to the Recreation Commission June 1999-March 2011). Jacki will take care of this.
